京都大学東南アジア地域研究研究所 ポストドクトラルフェロー Post-Doctoral Fellow, Center for Southeast Asian Studies (CSEAS), Ph.D



Dr. Andrey Damaledo is a research fellow at the Center for Southeast Asian Studies (CSEAS) at Kyoto University. He holds a PhD in Anthropology from The Australian National University (2016) and an MA in Advanced Development Studies from the University of Queensland (2009), both as an Australian Award scholar. He was the recipient of the Australian Department of Foreign Affairs and Trade (DFAT) Allison Sudradjat Prize.

He was also awarded the Ann Bates Prize 2017 for producing the most outstanding PhD thesis on Indonesian studies at ANU. His research focuses on migration, conflict and reconciliation, border issues, development planning and public policy. He is now embarking on a new research to investigate the notions of transnationalism and mobilities in Indonesia and Timor-Leste.

オーストラリア国立大学で博士号(人類学 2016 年)を、クイーンズランド大学で修士号 (Advanced Development Studies 2009 年)を取得。オーストラリア外務通産省 Alison Sudradjat 賞受賞。移民、国境紛争と和解、開発計画、公共政策などをテーマに研究を行う。現在は、トランスナショナリズムの概念や、インドネシアと東ティモールにおけるモビリティ(人の移動性)について調査を進めている。

(Goethe Institute, Sofia) and is currently in charge of the international project "AWARE: Multi-agency training for working with prisoners and former prisoners".
